## **1 ANNOUNCEMENT**

AUTOMOTO club in ACCR Hořice organises an open road racing event “**61<sup>st</sup> year 300 curves of Gustav Havel**” held in **18<sup>th</sup> – 19<sup>th</sup> May 2024** for the following categories:

- 125 SP** - Open ACCR RR Championship - “**Martin Turna Memorial**”  
**125 GP / Moto 3** - Czech Republic ACCR RR Championship - “**Hořice Cup**”  
**250 Open** - Czech Republic RR Championship – “**ALPRIM Cup**”  
**Supersport 300** - Open ACCR RR Championship – “**TIYO Cup**”  
**Supersport 400** - Open ACCR RR Championship – “**Beton Transport Cup**”  
**Supertwin** - Open ACCR RR Championship – “**Toyota AutoStyl Trutnov Cup**”  
**Supermono** - Open ACCR RR Championship – **Filip Strnad Memorial**,

## **3 CIRCUIT**

Length: 5 150 metres

Width: 7 - 9 metres

Maximum difference in altitude: 90 metres

The circuit is technically difficult; it has 26 curves - 15 right and 11 left. Surface of the circuit is asphalt. Direction of the race is clockwise. Pole position is on the left side.

The starting grid is 3+3+3. Boxes are at the area of the start/finish line and visibly separated from the circuit. The number of mechanics in the boxes can be limited by the organizers. A plan of the circuit is enclosed.

## **4 JURISDICTION**

The event will be held in accordance with the ACCR General sporting code, ACCR road racing regulations and according to these supplementary regulations.

## **6 CATEGORIES AND CLASSES**

Motorcycles must follow the valid technical rules of the ACCR motorcycle sport.

The sport event is open to all riders with an ACCR national licence or higher and to riders with appropriate licences of other National Federations (FMN). Foreign riders, holders of a licence of other than ACCR, must submit a **starting permission** during the administrative inspection.

All number plates and numbers must be in accordance with the ACCR Technical rules for road racing motorcycles and must be provided by the riders themselves. Czech riders use their permanent numbers. **Organizers assign numbers to the foreign riders that will be mentioned in the list of approved riders.** Starting numbers must be visible from the front part and both sides of the motorcycle.

**Qualifying limit is announced for all classes.**

## **7 NUMBER OF RIDERS ALLOWED**

The maximum number of riders allowed is following:

## **8 ENTRIES, ENTRY FEE**

Rider registration will be done by **filling out an electronic application** form at [www.amkhorice.eu](http://www.amkhorice.eu). After filling out the application form, each rider will be automatically sent an email with payment information.

The official entry form must be delivered to the organizer not later than **April, 26<sup>th</sup> 2024 to 24:00**. Entry forms received after the deadline may not be accepted. By sending the entry form to the AMK Hořice riders are obliged to follow these Supplementary regulations and necessary changes. Entry forms that do not contain required information may not be accepted. Organizers do not confirm received entry forms. Organizers reserve the right to refuse any entry form. List of approved riders will be published after the deadline on [www.amkhorice.eu](http://www.amkhorice.eu) Riders participating Hořice for the first time will send the results of the previous races to [info@amkhorice.cz](mailto:info@amkhorice.cz).

The organizer asks the riders to use the e-mail: [paddock@amkhorice.cz](mailto:paddock@amkhorice.cz) to book the accommodation during the sport event. Accommodation in the paddock will be provided only to riders confirmed for the race. The accommodation is not covered by the organizers. The organizer reserves the right to limit the number of persons accommodated in the paddock per rider.

The deposit includes a premium for liability insurance of the event of the participant. The paid deposit is returned only in the case of a proper apology for the rider's non-participation before the start of the administrative inspection.

**A fine of 500 CZK is payable for late entry fee payment. If the rider does not have the entry fee paid by the entry deadline, he may not be accepted by the organizer.**

## **9 ADMINISTRATIVE AND TECHNICAL INSPECTION**

Riders who do not comply with the schedule for administrative and technical controls will not be allowed to take part in the event.

It is strictly forbidden to ride a motorcycle on the race track outside the official practice or race time.

**Newcomers are obliged to declare at the administrative inspection that they are starting for the first time. Here, in exchange for a guarantee of 500,- CZK or 20 Euro, they will receive a reflective vest in which they will go for Saturday's practices .**

Technical inspection in front of the administrative building ATC:

Riders are obliged to come for the Technical inspection and submit for checking: required rider's equipment and technical documentations from the bike. In case of accident the technical checking must be repeated.

**Rider's briefing will take place on Friday 17.5.2024 at the start /finish area and is mandatory for all riders. Briefing in Czech is at 7pm and briefing for foreign riders in English is at 8pm.**

## **10 PADDOCK**

Paddock is a part of the accommodation facilities Autocamp "U Věže" AMK Hořice. Area of the paddock is fenced and at the time of the event is limited access to the public- only riders with their teams are accommodated in the camp and spectators are allowed to enter the paddock only with the valid ticket.

**Reservations for the place in the paddock** should be sent to [paddock@amkhorice.cz](mailto:paddock@amkhorice.cz) by **10.5.2024**.

The paddock will be open **on Thursday, May 16<sup>th</sup> 2024 and on Friday, May 17<sup>th</sup> 2024 from 8am to 10pm**. Every participant must respect the instructions of the officials and organizers. **All riders must be in the paddock on Saturday, May 18<sup>th</sup> 2024 by 07:30 am** at the latest! The circuit will be closed at 08:00 am and the access to the paddock will not be possible then.

On the arrival to the paddock each rider must report at the main gate. Only then can be taken the place assigned by the organizer to the rider and the team. Space will be allocated by the organizer.

**Each rider and the team must follow these Supplementary Regulations and the instructions of the officials and staff of the organizer during the sporting event from Thursday 16.5.2024!**

**Each rider is responsible for all members of the team.**

**Parking of the personal cars is strictly prohibited in the paddock and may only be allowed in exceptional cases. Car parking is allowed along the fence in the back half of “Cesta Legii” and in the back meadow.**

Night rest in the paddock is from **11pm to 7am**. Rider will not be admitted to the practice or the race for not following the instructions and regulations of the organizer.

**The organiser reserves the right to offer an alternative if your requirements cannot be fully met due to capacity. In case you won't have a reservation, you will be allocated a place according to the available capacity. In case of more applicants for one place, the organizer will take into consideration the number of starts, previous results or standings in previous years.**

Rider must complete **a total of at least 5 laps in the participating category** during the qualifications to be classified for the race. The schedule is preliminary and it can be changed in case of need and according to the number of riders in each category.

## **13 PRIZES**

The ceremonial announcement of the three most successful riders in each race will be made after the morning and afternoon programme of races. The national anthem will be played in honour of the winner.

The prizes for the placings will be paid one hour after the results are published at the organizer's secretariat. The amount of the prize money is fully dependent on the rider's position in the race. The

condition is the rider's classification in the race. If the number of riders in any class is less than 10, the riders from that race will receive 50% of the prize money for placing. If the number of starters in any class is less than 5, riders will not receive any prize money. Unclaimed prizes and prize money will be forfeited to the organiser.

#### **14 PROTESTS**

All protests must be submitted in writing to the clerk of the course or to a designated representative in accordance with the ACCR Disciplinary and Arbitration Rules and accompanied by a fee of 5 000 CZK.

#### **15 DRUG AND ALCOHOL TESTING**

During the event, the organiser will check riders for prohibited substances and alcohol. The rider is obliged to submit to them. In case of refusal the check, the rider will be excluded from the event.

#### **16 FUEL**

Used fuel must be in accordance with article 2.10 of the FIM Technical Rules for road racing motorcycles. Petrol station is available in the city.

#### **17 INSURANCE**

In accordance with the article 110.1 of the ACCR Sporting Code, the organizer's liability insurance and responsibility of riders, competitors and officials, in case of an accident caused to the third party during the whole sport event is in the responsibility of the organizers.

The organizer is obliged to arrange an insurance of participants for damage caused by the motorcycle during the sport event. The payment of this insurance is included in the entry fee. The number of the insurance contract: C550012623.

The organizer disclaims all responsibility for damage to motorcycle, its accessories and components arising out of an accident, fire or other cases.

By endorsing the application form for entry, the National Federation of the rider certifies that the rider is insured in accordance with the FIM Europe requirements.

#### **18 LIMITATION OF LIABILITY**

Apart from the requirements of the ACCR Sporting Code, participants (incl., but not only: competitors, riders, mechanics, guests etc.) by participating renounce all rights of appeal against the organizer, his representatives or agents by arbitration or before a tribunal or any other manner not foreseen by the ACCR Sporting Code for any damages for which they could be liable in consequence of all acts or omissions on the part of organizer, his officials, representatives or agents in the application of these regulations or contributed to or arising out their actions.

#### **19 PARKING OF TRUCKS AND LARGE VEHICLES**

**Please note that the capacity for large cars (trucks) is limited and once full, parking will no longer be possible in the paddock. We recommend that you check availability in advance (in this case, advance booking is required!!!)**

#### **20 PADDOCK – EXIT TO THE TRACK AND RETURN TO THE PADDOCK**

##### **RIDERS**

For safety reasons, only riders with racing motorcycles are allowed to leave the main gate of the paddock for practice! At the end of the practice or race, riders will complete the lap slowly and will

be diverted by the organizer on the finishing straight to the “Cesta Legii” and then admitted to the paddock through the side entrance.

## MECHANICS

### Saturday:

The main gate of the paddock is used ONLY for the exit of race bikes to the practice. Because of the safety of the riders outgoing to the practice it is **STRICTLY PROHIBITED** to the mechanics to go through this gate during the training on Saturday. The mechanics have to use the bridge to go to the boxes (only without carriages) or **in case of transporting the carriages into the boxes mechanics have to use** a side entrance to the paddock and then the sidewalk to the boxes. After the training session, the mechanics return the same way back!

### MECHANICS – SUNDAY:

On Sunday mechanics are allowed to go with the carriages to the grid as soon as all race bikes leave the paddock to the seeing lap of the race.

Mechanics have to leave the area in front of the main gate into a special area which is situated on the right sight to enable a safety exit of the race bikes into the training or the seeing lap of the race for the whole weekend.

Breaking of this regulation will be punished in the following way. The box entry ticket of the mechanic will be removed by the organizer’s staff and the rider of this mechanic will be questioned by the Jury of the race. There may be only mechanics of the relevant category in the boxes.

**Minors are not allowed on the starting grid or in the pits.**

The organizer is not liable for damage to electrical equipment of race participants due to outages and drop in voltage in the power grid. **In the event of overloading the system, disconnection of water heating or other parts of the network may occur.**

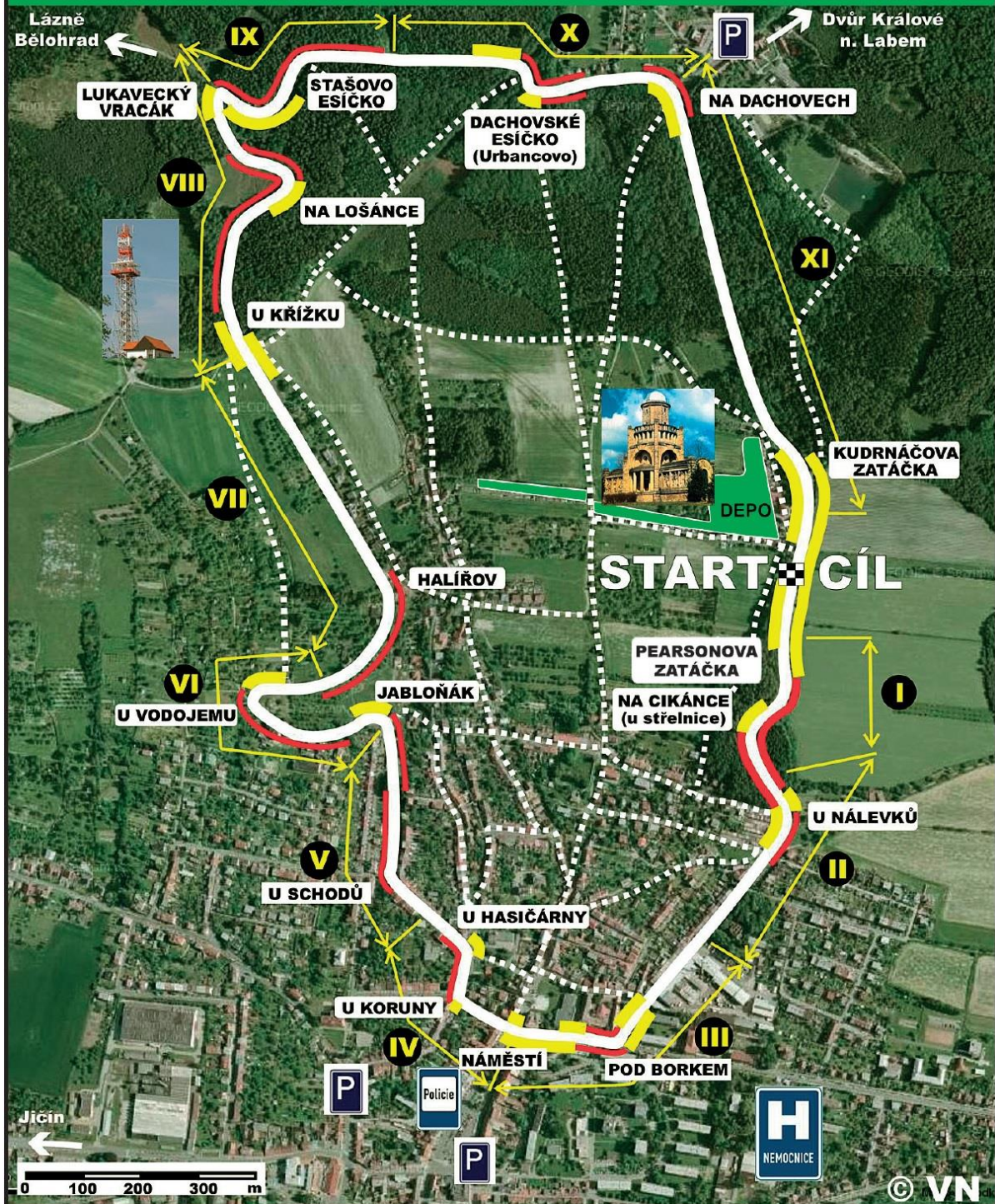
